Message From Our Board President





The Go Green Initiative runs two collaborative summer internship programs, with its flagship program in GGI incubator district Pleasanton, California and the second available to students across the country. In this year's program, interns worked to reduce short-lived climate pollutants by promoting community compliance with waste reduction and diversion laws.

Sixty-six students participated, representing six cities: Compton, Hayward, Madera, Oakland, and Pleasanton, California, as well as Mendota, Illinois. Each contributed to five outcomes for their respective communities:

- City-wide outreach campaigns
- 50+ community education presentations
- 5-week social media toolkit
- Residential & business infographics
- Presentations to community leadership

NUTRITION ON THE MENU IN NEWARK

Our Local Leaders at West Side High and Central High in Newark, New Jersey are on a mission for nutrition!

They formed the **Nutrition Advisory Council:** a joint effort between students and district administrators to improve nutrition and cultural inclusion in school meals.
Collaborating with their district's Executive Director of Food Services, they've proud of the changes they've seen to the menu.

CHESTER'S TECHIE FRESH FOOD SOLUTION

STEM Academy Local Leaders in Chester, Pennsylvania are serving up fresh food to their community! With expert input from the Green Bronx Machine, they built **indoor aeroponic tower gardens** and wrote a proposal to secure heating for their **outdoor greenhouse garden**. The fruits of their labor are are donated to an afterschool culinary program.


HAYWARD STUDENTS LEAD DISTRICT CHANGE

Students at Tennyson High School in Hayward, California are serious about their **campus' climate impact.** They formed a Green Team this year and have conducted a bin-ventory and waste audit to assess next steps for compliance with SB-1383, state law that requires schools to recycle and compost, as well as recover edible food. They're bringing their concerns to the **District Green Team and School Board** to secure the equipment and support they need to make it happen.

The team is preparing a campus-wide campaign to teach their community how to prevent waste contamination and **minimize greenhouse gas emissions**. They're also the first young people to meet with the **City of Hayward** to provide feedback on the city's Climate Action Plan and are working to secure more student input for the city's plan.

Engaged Citizens Public Policy Partnernships



In the GGI's home district, Local Leaders at Amador Valley and Foothill High Schools continue to lead the way in their schools and community.

Expanding on work by our interns, these Local Leaders partnered with City Councilmembers and City Staff to conduct city-wide outreach on waste reduction and diversion compliance and host a screening of GGI intern-produced water conservation documentary "Hometown Water: the Lifeline of Pleasanton". Their event was well-attended by city management, public policymakers, and the community.

They also joined forces with their senior district administrators to optimize recycling and organics programs on campus, re-launch food share and waste tracking programs, and evaluate districtwide compliance with SB 1383. "One of the most valuable things I learned in Local Leaders is how to work with and lead a team and how even as a high school student, I could influence public policy.

NEWARK AIMS FOR SILVER CERTIFICATION

NEWARK, NJ

In 2021, Newark Board of Education set its sights for Sustainable Jersey for Schools Silver Certification for all its campuses and the GGI is helping them make the grade.

Supporting the district and school to implement and evaluate their qualifying programs, the GGI created customized training for schools and worked with senior NBOE administrators across departments to document sustainability action and analyze two years of utility data for 68 school sites.

The GGI has supported the district in each component of their sustainability plan, including:

- Energy tracking & management
- Energy efficiency
- District sustainability policy
- Green purchasing policies
- Safe routes to school
- Professional development
- Green enhancements for district strategic plans
- Student participation in the arts
- Healthy food beyond the cafeteria
- · Promoting locally grown food
- Breakfast after the bell
- Green cleaning
- Digital teaching & learning

CAMDEN SCHOOLS SEEK BRONZE CERTIFICATION

CAMDEN, NJ

This year, the GGI has supported Camden City School District with applications for all of its 17 schools to go for Bronze Certification by Sustainable Jersey for Schools. These applications are the culmination of long-standing efforts by the District, in partnerships with the GGI, to achieve environmental health and sustainability, including efforts to:

- track and conserve energy use
- locally source fruits and vegetables
- install edible gardens
- facilitate access to healthy food options outside of the cafeteria
- achieve green cleaning
- and improve indoor air quality

Their applications document five schools that have reduced their energy usage by 10% since 2018 and numerous other achievements across departments and facilities.

COMPTON LAUNCHES DISTRICT GREEN TEAM

COMPTON, CA

The GGI's partnership with Compton Unified School District began in 2020 with the participation of CUSD students in our **internship program**. In 2021, the Go Green Initiative launched District Services within the CUSD, supporting senior administrators and the School Board to prepare for compliance with SB 1383 across campuses and facilities.

In progress toward that goal, CUSD has formed a **District Green Team**, chaired by the head of the Business Services department, and maintaining commitment from senior facilities staff, parent liaisons, school administrators, and students, including GGI internship program participants. The GGI has provided training on SB 1383 and specific tactics to bring all school sites into compliance. We look forward to seeing CUSD through to meeting its goals to institute **recycling and composting** programs across the District, and to **recover edible food** in accordance with the law.

Chester Builds

Social Infrastructure for Success



The GGI has been working with Chester Upland School District **since 2015**, achieving success in student services at STEM Academy and in community-based programs to **promote nutrition and healthy lifestyles**. This school year, the GGI met with Superintendent Dr. Parkinson and senior staff to lay the groundwork to establish a **District Green Team** and district-wide sustainability plan.

Despite a tumultuous school year that required numerous pivots between in-person and at-home instruction, the District's **commitment to creating a healthy, sustainable learning environment** is stalwart. We look forward to continuing to expand the GGI's District Services in Chester Upland in the 2022-23 school year.





OUR INCUBATOR DISTRICT PILOTS REPLICABLE SUCCESS

Pleasanton USD is tackling short-lived climate pollutants with replicable waste tracking success.

PLEASANTON, CA

Returning to the classroom from remote learning, the GGI supported PUSD to swiftly re-launch their on-campus integrated waste management programs. The district team assessed needs for bins and equipment and re-established **Green Teams** at all school sites, each trained by the GGI to achieve school-wide compliance with SB-1383 and **keep short-lived climate pollutants out of the landfill**. Administrators, teachers, custodians, and students at each site collaborated to educate their campus community, ensure successful recycling and organics programs, relaunch food share, and measure their success.


Their work to track waste allows the district to measure environmental impacts, quantify diversion success, save money on waste hauling, and optimize the program on each campus.

The district has continued to utilize the **Energy Star Portfolio Manager** to analyze utilities and achieve savings. Their case study is helping us build a toolkit to replicate their success across the country.
